General Data Protection Regulation (GDPR)

We are a Data Controller of your information.

Log Files

[irvmarcusacupuncture.com](http://irvmarcusacupuncture.com) follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and a part of hosting services' analytics. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information is for analyzing trends, administering the site, tracking users' movement on the website, and gathering demographic information.

## Cookies and Web Beacons

Like any other website, irvmarcusacupuncture.com uses 'cookies'. These cookies are used to store information including visitors' preferences, and the pages on the website that the visitor accessed or visited. The information is used to optimize the users' experience by customizing our web page content based on visitors' browser type and/or other information.

We only use one cookie on Vistaprint hosted websites. We use this cookie to count the number of unique visitors, so we know how many people visit the websites we host and to report that to irvmarcusacupuncture.com's website dashboard. This cookie is not used for anything else beyond this. It does not use or store any personally identifiable.

## Privacy Policies

Third-party ad servers or ad networks uses technologies like cookies, JavaScript, or Web Beacons that are used in their respective advertisements and links that appear on irvmarcusacupuncture.com, which are sent directly to users' browser. They automatically receive your IP address when this occurs.
